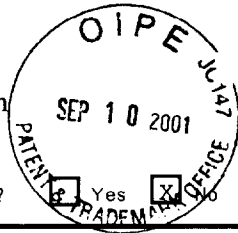

ASSIGNMENT

WHEREAS, we, Rick L. Allison, of Apex, North Carolina, and Thomas M. Assignors further covenant and agree that, at the time of the execution and delivery of these presents, Assignors possess full title to the invention and application above-mentioned, and that they have the unencumbered right and authority to make this assignment.






