WHEREAS, Rocky Mountain Sports, Inc., a Colorado corporation having a place of business at 650 S. Assignor further authorizes Assignee, its successors and assigns, or anyone Assignee may properly designate, to apply for Letter Patent, in Assignee's own name if desired, in any and all foreign countries, and additionally to claim the filing date of the Patent and/or otherwise take advantage of the provisions of the International Convention.


Upon said consideration, Assignor does hereby covenant and agree with Assignee, its successors and assigns, that Assignor has not and will not execute in writing or do any act whatsoever conflicting with these presents, and that Assignor or Assignor's executors or administrators will at any time upon request, without further or additional consideration, but at the expense of Assignee, its successors and assigns, execute such additional writings and do such additional acts as Assignee, its successors and assigns, may deem necessary or desirable to perfect Assignee's enjoyment of this grant, and render all necessary assistance in making application for and obtaining original, divisional, continuation, continuation-in-part, reissued, reexamined, substituted or extended Letters Patent of the United States, or of any and all foreign countries on said invention, and in maintaining and enforcing any rights occurring as a result of such applications or patents, by giving testimony in any proceedings or transactions involving such applications or patents.

Assignor hereby irrevocably assigns to Assignee all claims for damages by reason of past infringement of any patent or other such right arising or occurring as a result of such applications or patents, with the right to sue and collect such damages, and Assignor agrees to cooperate fully in any action to collect such damages.

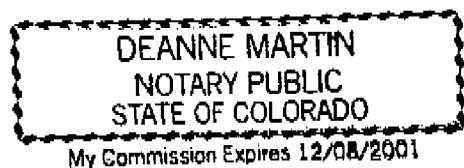
