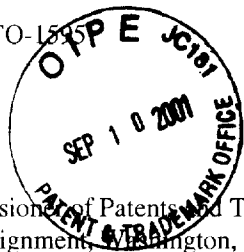


## ASSIGNMENT

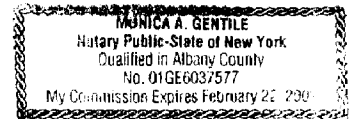

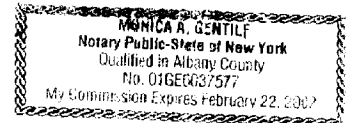

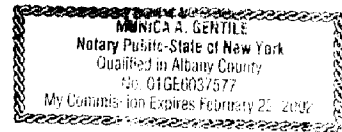
