ASSIGNMENT

WHEREAS, I, Jens Dieckröger, of München, Germany hereinafter ("Assignor"), have invented certain new and useful improvements in INTEGRATED TRANSVERSE ELECTROMAGNETIC WAVE ARRANGEMENT, PROCEDURE FOR PRODUCTION OF AN INTEGRATED TRANSVERSE ELECTROMAGNETIC WAVE ARRANGEMENT, AND PROCEDURE FOR THE PRODUCTION OF TRANSVERSE ELECTROMAGNETIC WAVE ELEMENTS for which application for a U.S. Letters Patent was made on July 5, 2001 as Application Serial No. 09/899/493 (claiming priority to German Patent Application No. 100 32 933.0 filed July 6, 2000).

AND, WHEREAS, Infineon Technologies AG, a corporation duly organized and existing under the laws of the Germany, having its principal office and place of business at St.-Martin-Str. 53, 81669 München, Germany (hereinafter "Assignee"), is desirous of acquiring an interest therein.

NOW, THEREFORE, To Whom It May Concern, be it known that for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor has sold and by these presents does hereby sell, assign, transfer and convey unto the said Assignee, its successors and assigns, his entire right, title and interest in and to the said invention and application, and in and to any and all continuations, continuations-in-part, or divisions thereof, and in and to any and all Letters Patent of the United States of America and all foreign countries or reissues thereof which may be granted therefor or thereon, for the full end of the term for which said Letters Patent may be granted, together with his right to claim the priority of said application in all foreign countries in accordance with the International Convention, the same to be held and enjoyed by said Assignee, its successors and assigns, as fully and entirely as the same would have been held and enjoyed by Assignor if this assignment and sale had not been made.

Assignor hereby requests that said Letters Patent be issued in accordance with this assignment.

Assignor further covenants and agrees that, at the time of the execution and delivery of these presents, Assignor possesses full title to the invention and application above-mentioned, and that he has the unencumbered right and authority to make this assignment.

Assignor further covenants and agrees, and likewise binds his heirs, legal representatives and assigns, to promptly communicate to said Assignee or its

representatives any facts known to them relating to said invention, to testify in any interference or legal proceedings involving said invention, to execute any additional papers which may be requested to confirm the right of the Assignee, its representatives, successors and assigns to secure patent or similar protection for the said invention in all countries and to vest in the Assignee complete title to the said invention and Letters Patent, without further compensation, but at the expense of said Assignee, its successors, assigns and other legal representatives.
