WHEREAS, Paul T. Van Gompel, David A. Fell, Jacqueline A. Gross, Yung H. Huang, Michael T. Morman, and Thomas H. 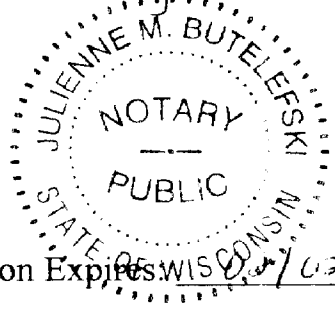
