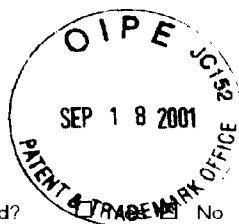

ASSIGNMENT

Whereas, I, HOLGER BEHRENDTS of Am Tiergarten 60, 30559 Hannover, Federal Republic of Germany, have invented certain new and useful improvements in Air Spring having Two End Members and a Distance Sensor Mounted therebetween for which application for United States Letters Patent has been executed on even date herewith, (said application having Attorney Docket No. 200-026); and,

Whereas, CONTINENTAL AKTIENGESELLSCHAFT, a corporation organized and existing under the laws of the Federal Republic of Germany, having its principal office at Vahrenwalder Strasse 9, 30165 Hannover, Federal Republic of Germany (hereinafter referred to as CONTINENTAL), is desirous of obtaining Letters Patent for said invention in the United States;

I agree for myself and for my heirs, executors and administrators to communicate to said CONTINENTAL, its successors, assigns, nominees or other legal representatives, all facts known to me respecting said improvements, whenever requested, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and do all lawful acts requisite for the application, for such divisional, continuing or reissue

applications or the procuring thereof, and I further covenant and agree that I will, at any time upon request, do everything legally possible to aid said CONTINENTAL, its successors, assigns, nominees or other legal representatives, either in its or their own name, to maintain and enforce any patent for said improvements without further consideration but at the expense of said CONTINENTAL, its successors, assigns, nominees or other legal representatives.

I hereby authorize and request the United States Commissioner of Patents and Trademarks to issue any and all Letters Patent which may be granted upon any of said applications, to said CONTINENTAL as the Assignee of the entire right, title and interest in and to the same, for its sole use and behoof; and for the use and behoof of its successors, assigns, nominees, or other legal representatives, to the full end of the term for which said Letters Patent may be granted.
