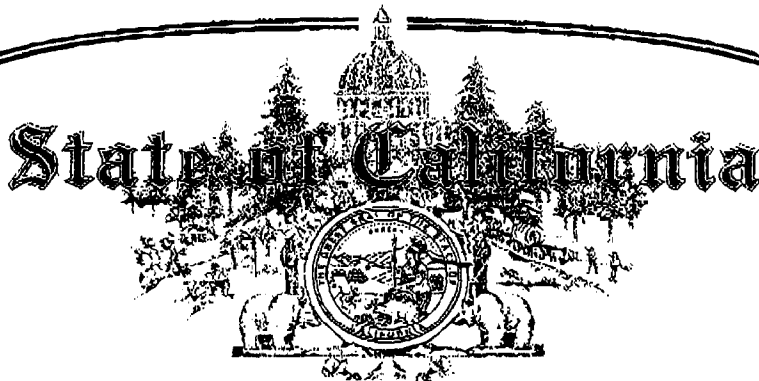

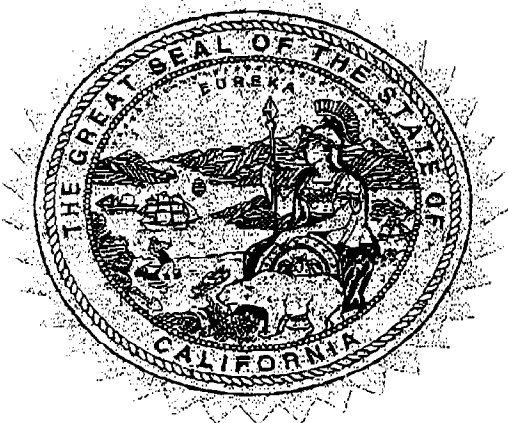

2. The following Amendments to the Articles of Incorporation has been approved by the Board of Directors of the Corporation:

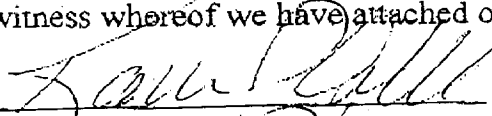
FIRST: Article I of the Articles of Incorporation is amended to read in its entirety as follows:

"First: The name of this corporation is WOMEN FOR HEALTH, INC."

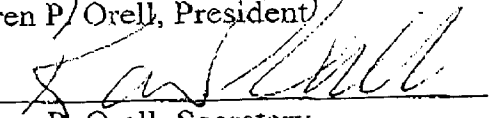

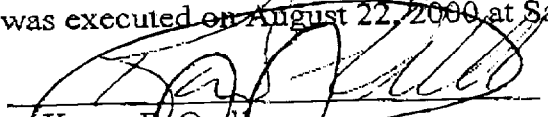


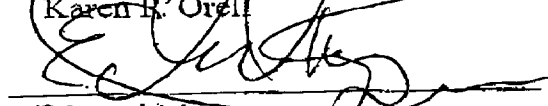
