## SOLE TO CORPORATE ASSIGNMENT

WHEREAS, the undersigned, William W. Oldfield, a resident of 413 Lakeview Way, Redwood City, California 94062, (hereinafter termed "Inventor"), has invented certain new and useful improvements in:

### METHOD OF MANUFACTURING A MICROSTRIP EDGE GROUND TERMINATION

and has executed a declaration or oath for an application for a United States patent disclosing and identifying the invention.

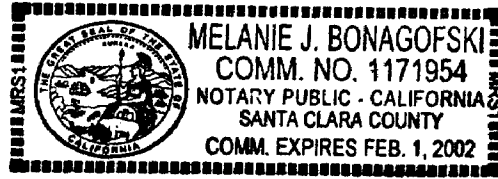
