Document Processing System Using Full Image Scanning

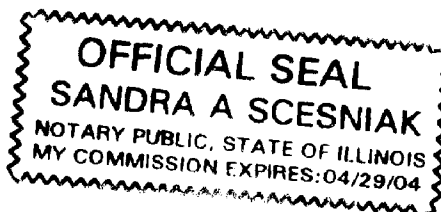




