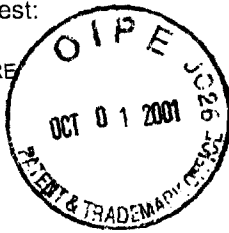

ASSIGNMENT

WHEREAS, CHRISTOPHER S. MOORE, BENDIK KLEVELAND, ROGER W. MARCH, JAMES M. CLEEVEs, and ROY E. SCHEUERLEIN, hereinafter called the "Assignors", have made the invention described in the United States patent application entitled METHOD AND SYSTEM FOR INCREASING PROGRAMMING BANDWIDTH IN A NON-VOLATILE MEMORY DEVICE, for a full description of which reference is here made to an application for Letters Patent of the United States filed on June 29, 2001, and assigned Application Serial No. 09/895,960;

vesting in the Assignee like exclusive title in and to all such other patent applications and patents; and in the prosecution of any interference which may arise involving said invention, or any such patent application or patent; and that the Assignors will execute and deliver to the Assignee any and all additional papers which may be requested by the Assignee to carry out the terms of this Assignment.

The Commissioner of Patents and Trademarks is hereby authorized and requested to issue patents to the Assignee in accordance with the terms of this Assignment.
