## ASSIGNMENT





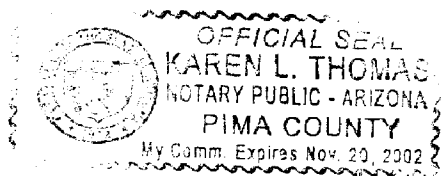
