I hereby authorize Assignee to apply for patents or counterparts in foreign countries directly in its own name, and to claim the priority of the filing date of the application for United States Letters Patent under the provisions of any and all international conventions or treaties.

I agree that, when requested, without charge to Assignee but at its expense, I will do all lawful acts, including the execution of all papers, taking all rightful oaths, giving of testimony, that may be necessary, desirable, or convenient for securing, maintaining, reissuing, and enforcing patents or counterparts for the inventions in any and all countries, and for perfecting, recording, vesting, or maintaining title in the inventions and the applications, and any patent or counterparts granted for the invention, in Assignee, its successors, assigns, and legal representatives or nominees in any and all countries.

I represent and warrant that I have not granted and will not grant to others any rights inconsistent with the rights granted herein.

I hereby authorize and request the Commissioner of Patents and Trademarks of the United States to issue any Letters Patent upon the application, division, extension, continuation, continuation-in-part, reexamination, or reissue, to Assignee, its successors, assigns, and legal representatives, to the full end of the term for which Letters Patent may be granted, the same as they would have been held and enjoyed by me had this Assignment not been made, and I hereby authorize and request the equivalent authorities in foreign countries to issue the patents or counterparts of their respective countries to the Assignee.
