WHEREAS, we now own the partial rights, title and interest therein, which shall be referred to as the "Inventive Subject-matter" in this Assignment; and



applications or patents, and by executing preliminary statements and other affidavits, it being understood that the foregoing covenant and agreement shall bind, and inure to the benefit of, the assigns and legal representatives of all parties.
