NOW, THEREFORE, TO ALL WHOM IT MAY CONCERN, be it known that for and in consideration of One Dollar (\$1.00), in hand paid, and other good and valuable consideration, the receipt of which is hereby acknowledged, effective July 1, 2001 the Assignor has sold, assigned and transferred, and by these presents does hereby sell, assign and transfer unto the Assignee the full and exclusive right, title and interest in and to the aforesaid applications and patents, the aforesaid inventions, and each and every patent that may be issued on the aforesaid applications and inventions in the United States of America, and in its territories and possessions and also in all countries foreign to the United States of America, the same to include the right to sue for past infringements, the same to be held and enjoyed by the Assignee for its own use and benefit, and for the use and benefit of its successors, assigns or other legal representatives to the end of the term or terms for which a patent or patents may be

granted as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made.

Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks to issue any and all Letters Patent on the aforesaid inventions or resulting from the aforesaid applications directly to the Assignee.

Assignor hereby authorizes the Assignee and its successors to apply for a patent or patents directly in its own name upon the aforesaid inventions wherever the same is permitted by law, and also assigns, sells, transfers and sets over the Assignee and its successors all priority rights under the aforesaid applications.

Assignor further covenants to execute all additional instruments and to do all things necessary to carry out the purpose of this instrument, at the expense of the Assignee and its successors.
