ASSIGNMENT

WHEREAS, We, WALTER MAYER, a citizen of Germany residing at KLINGENSTR.9, 85055 INGOLSTADT, GERMANY; and ADALBERT STEPHAN, a citizen of Germany residing at AM HAAR 23, 92339 BEILNGRIES/PAULUSHOFEN, GERMANY (hereinafter referenced as ASSIGNORS), have invented a certain new and useful invention entitled A PROCESS AND AN APPARATUS FOR THE SERVICING OF A TEXTILE MACHINE, for which an application for Letters Patent of the United States has been filed in the United States Patent and Trademark Office;

And we hereby agree, at the expense of ASSIGNEE, to testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, continuation-in-part, reissue, and substitute applications, make lawful oaths and declarations, and generally do everything possible to vest title in ASSIGNEE and to aid ASSIGNEE to obtain and enforce proper protection for said invention in all countries.

And we hereby agree to transfer a like interest, upon the request of said ASSIGNEE, its successors, assigns and legal representatives, and without further remuneration, in and to any improvements, and applications for patent based thereon, growing out of or related to the said invention; and to execute any papers by the said ASSIGNEE, its successors, assigns and legal representatives, deemed essential to ASSIGNEE's full protection and title in and to the invention hereby transferred.

Agreeing furthermore, upon request of said ASSIGNEE, and without further remuneration, to execute any and all papers desired by said ASSIGNEE for the filing and granting of applications and the perfecting of such right, title, and interest thereto in said ASSIGNEE.
