ASSIGNMENT

WHEREAS, I, Diane L. Peterson, a citizen of USA and resident of Addison, Dallas County, Texas, have invented certain new and useful improvements in "COMMERCE OPEN SYSTEM" for which I am about to make application for *United States Letters Patent*; and

WHEREAS, Atitania, Ltd., a corporation of the State of Texas, which has a business address of 12221 Merit Drive, Suite 1660, Dallas, Texas 75251-2251 (hereinafter referred to as "Assignee"), is desirous of acquiring my entire right, title and interest in and to the invention, and in and to said application and any *Letters Patent* that may issue thereon;

NOW, THEREFORE, for and in good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, I do hereby sell, assign and transfer unto said Assignee, its successors, assigns and legal representatives the full and exclusive right, title and interest in and to said invention and in and to said application and all patents which may be granted therefor, and all divisions, reissues, substitutions, continuations, continuations-in-part and extensions thereof; and I hereby authorize and request the Commissioner of Patents & Trademarks to issue all patents for said invention, or patents resulting therefrom, insofar as our interests are concerned, to said Assignee of my entire right, title and interest.

I further hereby agree that I will communicate to said Assignee, or to its successors, assigns and legal representatives, any facts known to me respecting any improvements and, at the expense of said Assignee, to testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, continuation-in-part, reissue and substitute applications, make all lawful oaths, and generally do everything possible to vest title in said Assignee and to aid said Assignee, its successors, assigns and legal representatives to obtain and enforce proper protection for said invention in all countries.
