extensions thereof to the said LOCKHEED MARTIN CORPORATION, as assignee of the aforesaid interest in and to the same.

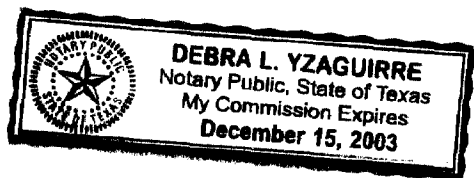
