### ASSIGNMENT

Whereas We, Frederick M. Rieber, whose residence address is 325 Weaver Road, Alum Bank, PA 15521, and Steven P. Hanson, whose residence address is 65 Harrison Street, North Kingstown, RI 02852-1111, have made certain inventions or discoveries (or both) set forth in an application for Letters Patent of the United States of America entitled SWING RIDE WITH BUBBLE GENERATOR, identified by Cesari and McKenna File No. 15750-0558, which application was executed by us on October 11, 2001; and

4. 5. affidavits in form and substance as may be requested by Assignee; to communicate to Assignee all facts known to us relating to said inventions and discoveries or the history thereof; and to furnish Assignee with any and all documents, photographs, models, samples, and other physical exhibits in our control or in the control of our heirs, legal representatives or assigns which may be useful for establishing the facts of our conceptions, disclosures, and reduction to practice of said inventions and discoveries.
