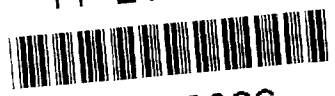

ASSIGNMENT

WHEREAS, American Cyanamid Company, a Maine corporation, having a place of business in Madison, New Jersey, USA (hereinafter "Cyanamid") and BASF Aktiengesellschaft, a German corporation having a place of business in Ludwigshafen, Germany ("BASF") entered into a Purchase Agreement dated March 20, 2000, as subsequently amended, wherein BASF purchased the crop protection business of Cyanamid (the "Agreement");

WHEREAS, under the terms of the Agreement, Cyanamid assigned to BASF its rights in certain patents and patent applications related to the crop protection business of Cyanamid, but such assignment has not yet been recorded with the respective government patent office such that the patents appear in the records of the respective government patent office to be assigned to Cyanamid; and

WHEREAS, Cyanamid desires to confirm the assignment of Cyanamid's rights in these patents and patent applications in a form suitable for recordation in the respective government patent offices.

NOW THEREFORE, Cyanamid agrees as follows:

1. As used in this Assignment, the term "Patents" shall mean the patents and patent applications listed in the Exhibit and all continuations, divisionals, continuations-in-part, reissues, reexaminations, counterparts in other countries and convention filings claiming priority thereto, as well as any patents issuing therefrom, and instruments similar to any of these in any country as the case may be.
2. Having the full right and authority to do so and in accordance with the terms of the Agreement, Cyanamid hereby assigns and transfers unto BASF, its successors and assigns, Cyanamid's entire right to, title to and interest in Patents effective as of July 1, 2000.
3. At the request of BASF and at BASF's expense, Cyanamid agrees to execute all oaths, assignments, powers of attorney, and other papers; testify in legal or quasi-legal proceedings; and generally do whatever is reasonably required to vest title to Patents in BASF, to defend Patents, and to establish the invention dates of the inventions respectively covered by the claims of Patents.
4. This Assignment is made subject to an exclusive, worldwide, royalty-free, fully paid-up, perpetual, transferable and irrevocable right and license, with the right to sublicense, in American Home

Products Corporation (a corporation existing under the laws of Delaware whose office is at Five Giralda Farms, Madison, New Jersey 07940, United States of America) in, under and to the Patents, outside the Agricultural Field and Chemicals Field, wherein, "Chemicals Field" shall mean industrial chemicals, such as polymer products and additives, coatings and resins, papers chemicals, mining chemicals, water treating chemicals, dyes, pigments, adhesives and composites; and "Agricultural Field" shall mean plant agriculture, horticulture, aquaculture, forestry, fruits, vines, vegetables, greenhouse and horticulture product systems, including applications relating to plant and crop protection, plant health, plant growth, plant modification/manipulation, plant production, plant disease and stress resistance, including (a) the development of commercial products and systems therefor, whether chemical or biological in nature, such as but not limited to, seeds, genetically engineered plants and parts thereof and foodstuffs, feedstuffs and other compositions made therefrom, plant growth regulators, herbicides, insecticides, acaricides, nematocides, fungicides, rodenticides, agents for the protection during transport or storage of harvested agriculture, horticulture, aquaculture, and/or forestry products; and including the home and garden, consumer, industrial, commercial, and public health markets therefor; and (b) plant-based production systems, including tissue culture, of pharmaceuticals, Nutraceuticals, industrial products and/or chemical intermediates, including the development and commercialization of commercial products and systems therefor, wherein "Nutraceuticals" shall mean a food, part of a food or other foodstuff or food supplement that may be marketed as having a specific health benefit, including the prevention, amelioration, eradication or other treatment of disease, and for the avoidance of doubt and other than as set forth above, "Agricultural Field" shall not include the "Plant Food Business" as that term is utilized in the context of those certain agreements between Cytec Technology Corporation and American Cyanamid Company relating to the divestiture of American Cyanamid Company's chemicals unit in 1993; or the Animal Health Business, wherein "Animal Health Business" shall mean the discovery, research, development, manufacturing, formulation, licensing, marketing, distribution and sale of products, including, without limitation, pharmaceuticals, nutritionals, pesticides and biologicals (including vaccines, antibodies, interleukins, somatotropins, large molecule therapeutics, proteins and peptides), as each of the foregoing may be used for the treatment, prevention, correction, amelioration, or diagnosis of disease, illness, injury or any other condition in non-human animals.
