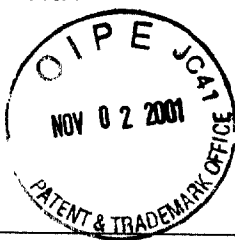

Bode, residing at 515 Partridge Drive, Albany, Georgia 31707 (each referred to as "Assignor") have made an invention(s) (the "Invention(s)") set forth in an application for patent of the United States, entitled Golf Club Head, and which is a:
