WHEREAS, I, Jenoe Tihanyi, of Kirchheim, Germany hereinafter ("Assignor"), have invented certain new and useful improvements in METHOD FOR FABRICATING A DRAM CELL HAVING A TRENCH CAPACITOR for which application for a U.S. Letters Patent was made on August 13, 2001 as Application Serial No. 09/913,422 (national phase application based on PCT/DE00/00435 filed February 15, 2000).

Assignor further covenants and agrees that, at the time of the execution and delivery of these presents, Assignor possesses full title to the invention and application above-mentioned, and that he has the unencumbered right and authority to make this assignment.

Assignor further covenants and agrees, and likewise binds his heirs, legal representatives and assigns, to promptly communicate to said Assignee or its representatives any facts known to them relating to said invention, to testify in any interference or legal proceedings involving said invention, to execute any additional

papers which may be requested to confirm the right of the Assignee, its representatives, successors and assigns to secure patent or similar protection for the said invention in all countries and to vest in the Assignee complete title to the said invention and Letters Patent, without further compensation, but at the expense of said Assignee, its successors, assigns and other legal representatives.
