PARTIES:

1. **TECHNICAL CASINO SERVICES LIMITED** of Unit 9, Mulberry Business Centre, Quebec Way, Rotherhithe, London SE16 1LB ("TCS") and
2. **MR PAUL TOWERS and MS TINA HERBERT** in partnership as **TOWERS ASSOCIATES** of Fell End Cottage, Yans Lane, Storth Milnthorpe, Cumbria LA7 7LJ ("TA")

RECITALS

- A. By an Agreement of 1st June 1995 ("the 1995 Agreement") TCS and TA entered into certain arrangements concerning an optical and electronic Auto Detect scanner head jointly developed by them ("ADH"). Pursuant to the 1995 Agreement Mr Paul Towers by an assignment dated 15th October 1996 assigned a one half share in the Patent Application number PCT/GB95/00933.
- B. It has been agreed to bring the 1995 Agreement to an end, extinguishing all further rights under it and to transfer to TCS all design, copyright, patent and other intellectual property rights in the ADH (together "the IP Rights") in return for the payment, as set out in this Deed.

This Deed now provides:-

1. TA hereby transfers to TCS its interest in the IP Rights in the ADH for £17,500 payable on signing this Deed.
2. TCS will offer TA the right to quote for the manufacture and supply from time to time of units of the ADH.
3. TCS will issue to TA a credit note for £6,500.00 plus VAT in respect of invoice No.

- 4.1 The 1995 Agreement is hereby terminated and any claims under it are hereby extinguished. For the avoidance of doubt TCS shall henceforth have the exclusive and absolute rights to the ADH, whether the rights of manufacture, marketing, sales, licensing, development or any other rights. TCS' absolute right to manufacture shall be subject only to the obligation of TCS in Clause 2 above.
- 4.2 Any claims which either party may at the date of this Deed have against the other in relation to any matter concerning the ADH or any technology having similar or equivalent effect are hereby extinguished.
5. TA will contemporaneously with this Deed execute a Deed of Assignment of certain patents, patent applications and registered designs in the form agreed between the parties and will at the expense of TCS execute any further documents that TCS may require to transfer all or any of the IP Rights in the ADH.
6. This is the whole agreement between the parties relating to the subject matter hereof.
7. This Agreement shall be governed by and construed under English law and the parties hereto submit to the jurisdiction of the English Courts.
8. It is hereby certified that this transaction does not form part of a larger transaction or series of transactions in respect of which the amount or value or the aggregate amount or value of the consideration exceeds sixty thousand pounds (£60,000).


