ASSIGNMENT OF INTELLECTUAL PROPERTY

THIS ASSIGNMENT is made the 11th day of September 2001

BETWEEN:

- (2) ALEXANDER JOHN WILLIAMS of 6 Milne Street, Irwell Vale, Bury BLO 9QP; and
- (3) **BOLTON ASSOCIATES** of I Kinross Close, Holcombe Brook, Bury BL9 5PN and 6 Milne Street, Irwell Vale, Bury BL0 9QP (together and separately "the Assignor")
- (4) **EURO PACKAGING PLC** whose registered office is Unit M, Waterloo Road, Yardley, Birmingham B25 8UH ("the Assignee")

RECITALS

- (A) The Assignor and/or each of them is the owner of the Intellectual Property Rights (as hereinafter defined).

 - "the Intellectual Property Rights" shall mean all patents including the Patents, utility models, design right, copyright (including copyright in computer software), trade marks, trade names and logos, inventions, trade secrets and other confidential information, know-how and all other intellectual and industrial property and rights of a similar or corresponding nature in any part of the world, whether registered or not or capable of registration or not and including the right to apply for and all applications for any of the foregoing rights and the right to sue for past infringements of any of the foregoing rights which came into being during the course of the Assignor's involvement with the Assignee.
- 2. Pursuant to the Agreement and in consideration of the sum of one pound (£1.00) now paid by the Assignee to the Assignor (the receipt of which is hereby acknowledged by the Assignor) the Assignor and each of them HEREBY ASSIGN to the Assignee such right, title and interest as they have free from all liens, charges and encumbrances in the Intellectual Property Rights together with all common law rights connected thereto and together with all the rights of actions, powers, benefits and immunities belonging to the same wherever in the world, including the right to sue for and obtain damages and other relief in respect of any act of infringement (whether past, present or future) of the

 - 3.2 To the best of the Assignor's knowledge and belief there are no persons entitled to claim any rights in the Patents nor to claim compensation from the Assignor pursuant to Section 40 of the Patents Act 1977 nor under equivalent laws of any other country in respect of the Patents,
 - 3.3 To the best of the Assignor's knowledge and belief the Patents do not and exploitation of the same by the Assignee will not infringe any valid and subsisting patent or any intellectual property rights of any other third party.
- The Assignor and each of them covenant with the Assignee that it will at the reasonable 4. cost of the Assignee execute within 14 days of any request all deeds and documents or other assurances and do all further acts and things at the reasonable cost of the Assignee as the Assignee may require in order to become the legal and beneficial owner of the Intellectual Property Rights to prosecute the Patents and otherwise to give effect to the terms of this Assignment.

 - to permit the Assignee to apply for patent protection or any other protection 5 1 available in respect of the inventions described in the Patents anywhere in the world and to grant and to ensure that any patents or other rights granted in respect of such inventions shall be granted to the Assignee or (if not practicable) to ensure full right and title thereto are subsequently vested in the Assignee,
