ASSIGNMENT OF DESIGN

WHEREAS, we, Carmen Lira-Núñez of 1615 15th Avenue SE #232, Sherburne County, St. Cloud, Minnesota 56304, James W. 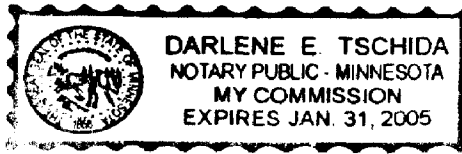
