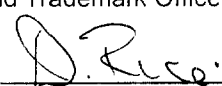

WHEREAS, I, Ralph Lance Carter, a citizen of Great Britain, reside at Corner Lodge, Chinnor Road; Nr Thame; Oxon OX9 3QY; Great Britain, and have made certain inventions or discoveries (or both) as set forth in an application for Letters Patent of the United States of America, entitled **Ellipsoidal Mirror**, bearing Patent Application Serial No. 09/942,019 and filed on August 29, 2001;

5.
