AMENDED PATENT ASSIGNMENT

This Amended Patent Assignment is made as of May ___, 2001, by and between TER-EL CO., Ltd., an Ohio limited liability company ("Assignor") and DIETRICH INDUSTRIES, INC., a Pennsylvania corporation ("Assignee") to amend and supersede the Patent Assignment dated as of February 6, 2001.

WHEREAS, Assignor is (i) a limited liability company duly organized and existing under and by virtue of the laws of Ohio and having a principal place of business at 1185 Lloyd Road, Wickliffe, Ohio 44092, (ii) the owner of the entire and exclusive right, title and interest in, to and under the United States and PCT (Patent Cooperation Treaty) patents and patent applications set forth on Exhibit A hereto and the respective inventions described and claimed therein, along with all rights arising under or pursuant to any and all international agreements, treaties or laws relating to the protection of intellectual property (collectively, the "Patent Rights"); and

WHEREAS, Assignee (i) is a corporation duly organized and existing under and by virtue of the laws of the Commonwealth of Pennsylvania and having a place of business at One Mellon Bank Center, Suite 2226, 500 Grant Street, Pittsburgh, Pennsylvania 15219 and (ii) desires to acquire the entire and exclusive right, title and interest in, to and under the Patent Rights.

WHEREAS, Assignor and Assignee desire to correct a typographical error made in the February 6, 2001 Patent Assignment wherein the provisional application serial number was incorrect.

NOW, THEREFORE, in consideration of One Million Five Hundred Thousand U.S. Dollars (\$1,500,000), plus the Deferred Payments (as defined in that certain Asset Purchase Agreement dated the date hereof between Assignor and Assignee) and other good and valuable consideration paid by the Assignee, the receipt and sufficiency of which is hereby acknowledged, the Assignor hereby sells, assigns, and transfers to the Assignee, its successors and assigns, the entire and exclusive right, title and interest in, to and under the Patent Rights, and all other patent rights that may be based thereon, including all renewals, divisions, substitutes, reissues, continuations, continuations-in-part, and all reissues or extensions thereof, and every priority right that is or may be predicated upon or arise from said Patent Rights, to the full end of the term and any extensions thereof for which said Patent Rights may be granted as fully and entirely as the same would have been held by the Assignor had this Assignment not been made.

The Assignor hereby acknowledges that this Assignment, being of the entire right, title and interest in and to the Patent Rights, carries with it the right in the Assignee to apply for and obtain from competent authorities, in all countries of the world, any and all Letters Patent by attorneys and agents of the Assignee's selection and the right to procure the grant of all Letters Patent to the Assignee, for its own name as assignee of the entire right, title and interest in and to the Patent Rights.


