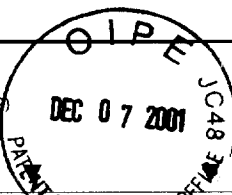

ASSIGNMENT

WHEREAS, Standard Plywoods, Incorporated (herein "Assignor"), whose principal office is at 384 Torrington Road, Clinton, South Carolina 29235, is the owner by assignment(s) duly recorded in the United States Patent and Trademark Office at Reel 9471, Frame 0436 for U.S. Design Patent No. 406,360, and at Reel 012097, Frame 0860 for U.S. Patent No. 5,797,237, by virtue of Assignments dated June 4, 1998 from the inventor, Donald R. Finkell, Jr. (hereinafter jointly "Patent Properties").
