NOW, THEREFORE, TO ALL WHOM IT MAY CONCERN, for a valuable consideration, receipt whereof is hereby acknowledged, I, the above named, hereby acknowledge my prior existing obligation and hereby sell, assign, and transfer to Assignee its successors and assigns, the entire right, title, and interest in the application and invention therein disclosed for the United States and foreign countries, to and under the said improvements, and the said application and all provisional, divisional, substitution, continuation applications thereof, and all Letters Patent of the United States which may be granted thereof and all renewals, reissues and extensions thereof, and all rights of priority under International Conventions and applications for Letters Patent which may hereafter be filed for said improvements in any country or countries foreign to the United States, and all Letters Patent which may be granted for said improvements in any country or countries foreign to the United States and all renewals, reissues and extensions thereof; and we request the Commissioner of Patents to issue any Letters Patent granted upon the invention set forth in the application to the Assignee, its successors and assigns; and we hereby agree that the Assignee may apply for foreign Letters Patent on the invention and we will execute all papers necessary in connection with the United States and foreign applications when called upon to do so by the Assignee.



And the Commissioner of Patents and Trademarks is hereby authorized and requested to issue all Letters Patent to the Assignee in accordance with the terms of the assignment.
