ASSIGNMENT AND AGREEMENT

For value received, I Yoshihiko Usami, a Japanese citizen, residing at 407 Carney Road, Greensburg, Pennsylvania 15601, hereby sell, assign and transfer to Sony Corporation, Tokyo, Japan, and Sony Electronics, Inc., Park Ridge, New Jersey, and its successors, assigns and legal representatives, the entire right, title and interest, for the United States of America, in and to certain inventions related to **Deflection Yoke With Multiple Pairs of Vertical Coils and Switched Deflection Current**, described in an application for Letters Patent of the United States, which application was executed on even date herewith, and identified by the Sony Electronics, Inc. I hereby consent that a copy of this assignment shall be deemed a full legal and formal equivalent of any document which may be required in any country in proof of the right of Sony Corporation and Sony Electronics, Inc. to apply for patent or other form of protection for said inventions and to claim the aforesaid benefit of the right of priority.

I request that any and all patents for said inventions be issued to Sony Corporation and Sony Electronics, Inc. in the United States and in all countries foreign to the United States, or to such nominees as Sony Corporation and Sony Electronics, Inc. may designate.

I agree that, when requested, I shall, without charge to Sony Corporation and Sony Electronics, Inc. but at its expense, sign all papers, and do all acts which may be necessary, desirable or convenient in connection with said applications, patents, or other forms of protection.
