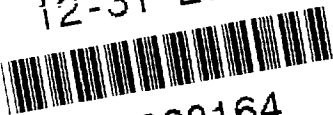

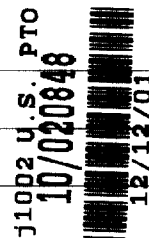

WHEREAS, I, BARNES COOPER, am the sole inventor of "OPERATING SYSTEM COORDINATED THERMAL MANAGEMENT" application for United States Letters Patent which is executed of even date herewith; and

And I do further covenant and agree that I will, at any time upon request, communicate to INTEL CORPORATION, its successors, assigns or other legal representatives, such facts relating to said invention and Letters Patent or the file history thereof as may be known to me, and testify as to the same in any interference or other litigation when requested so to do, without further compensation but at the expense of said assignee, its successors, or other legal representatives.
