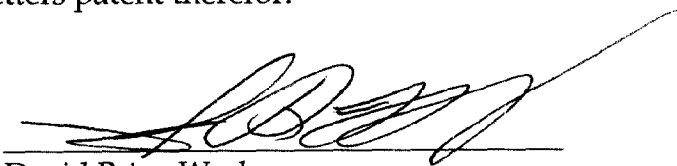
AGREEMENT
