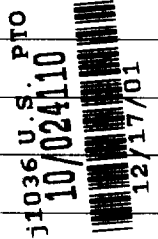

ASSIGNMENT

I, Robert R. Scott, of 12088 Shannel Circle, Riverton, Utah 84065, have invented a method and apparatus entitled HEAT SINK WITH GEOMETRIC ARRANGEMENT OF LED SURFACES, hereinafter called the "invention".
