other litigation when requested so to do, without further compensation but at the expense of said assignee, its successors, or other legal representatives.

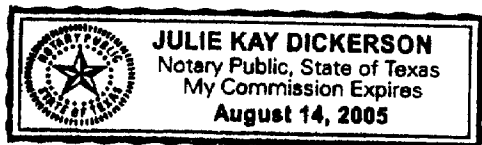

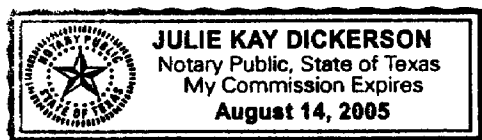

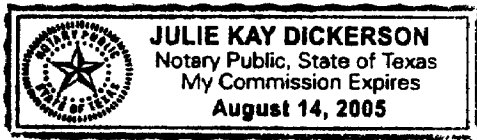
