**ASSIGNMENT**

WHEREAS, We, Phillip D. Neumiller and Dennis W. Davis, citizens of the United States of America, residing respectively at 301 Old Mary Cove, Lake Mary, FL 32746 and 207 East Woodward Avenue, Eustis, FL 32726, and Guénaél T.
