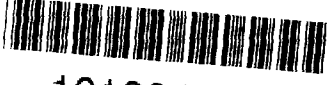


- (c) any and all refilings and continuations of said application;

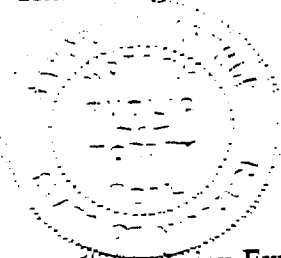
