WHEREAS, we, Jeffrey Schlom, residing at 10301 Sorrel Avenue, Potomac, MD 20854 U.S.A., a citizen of the United States of America; and James Hodge, residing at 19030 Montgomery Village Avenue, Gaithersburg, MD 20879, U.S.A, a citizen of the United States of America; have invented, along with coinventor Dennis Panacali, **A Recombinant Vector Expressing Multiple Costimulatory Molecules and Uses Thereof**, which application for Letters Patent of the United States of America has been filed on May 30, 2001, under Serial No. 09/856,988.
