

divisions, or continuations of letters patent granted for said inventions or upon said applications, to the full end of the term or terms for which said letters patent may be issued; and every priority or other right accorded by every international convention, treaty or agreement that is or may be predicated upon or arise from said invention, application and other applications or letters patent therefor, all to be held and enjoyed by Rocky Shoes & Boots, Inc., its successors and assigns, all the same as I would have held and enjoyed had this Assignment not been made;

I authorize and grant the right to Rocky Shoes & Boots, Inc. to file and prosecute patent applications in all countries for any part of said invention in my name or in the name of Rocky Shoes & Boots, Inc. or otherwise, as Rocky Shoes & Boots, Inc. may deem advisable under any international convention, treaty, or agreement or otherwise;

I authorize the Commissioner of Patents and Trademarks of the United States and the empowered officials of all other countries to grant, issue and transfer any letters patent for the said inventions arising out of said application to Rocky Shoes & Boots, Inc., as assignee of the entire right, title and interest therein, in accordance with this instrument of assignment;

I represent and warrant that there are no rights or interests outstanding inconsistent with the rights and interests granted herein; I covenant that I will not execute, grant, or transfer any rights or interests inconsistent herewith; I bind myself to execute and deliver to Rocky Shoes & Boots, Inc., its successors and assigns, any further documents or instruments and to perform any further acts that may be deemed necessary to enable it, its successors and assigns to file the said applications for letters patent for the said invention in any country in which it may elect to file such applications, and to vest in Rocky Shoes & Boots, Inc., its successors and assigns, the title herein conveyed and intended to so be conveyed, and to enable such title to be recorded in the

United States and each foreign country in which each such application may be filed so that any patent issued thereon shall be issued to Rocky Shoes & Boots, Inc., its successors and assigns; and I further cover ant and agree that, upon request, I will communicate to Rocky Shoes & Boots, Inc., its successors and assigns, any facts relating to the said invention and the history thereof, known to me and that I will testify as to the same in any interference or other litigation when requested to do so by Rocky Shoes & Boots, Inc., its successors and assigns.
