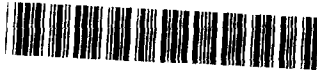

## ASSIGNMENT


