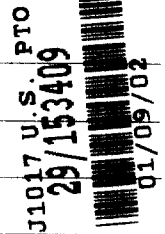

# ASSIGNMENT OF INVENTION


