
ASSIGNMENT

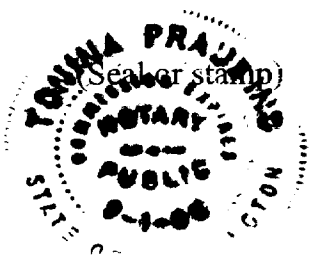
