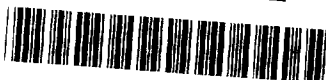





**PATENT ASSIGNMENT TO CORPORATION WORLDWIDE**

WHEREAS,

- 1. Tuomo Hokkanen residing at Stromsinlahdenkuja 2 a 13, 00820 Helsinki FINLAND and a citizen of FINLAND;
