AGREEMENT AND ASSIGNMENT

WHEREAS, **LI MO**, an individual residing at 4585 Spencer Drive, Plano, Texas 75024, (“Inventor”) have invented solely or jointly with others certain new and useful inventions (“Inventions”) disclosed in the patent applications and invention disclosure reports identified on the attached Schedule A.

To the extent that Inventor possesses any right, title and interest in the Inventions, including any of the forgoing Applications, Patents and Other Rights, Inventor hereby sells, assigns and transfers unto FNC, its successors, assigns and legal representatives all such right, title and interest.

Inventor hereby authorizes and requests the appropriate governmental officials to issue any and all such United States and foreign letters patent or resulting from any of the applications on the Inventions to FNC as the assignee of the entire right, title and interest in and to the same.

Inventor further covenants and agrees that Inventor will at any time upon request make, execute and deliver without further compensation, any and all other instruments in writing, including further applications, papers, affidavits, power of attorney, assignments, and other documents, and do all lawful acts and things, which, in the opinion of counsel for the Assignee, its successors and assigns, may in any country be required or necessary more effectively to secure to and vest in the FNC, successors and assigns the entire right, title and interest in and to the Inventions and other rights and interests referenced above.

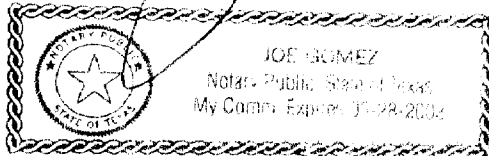
