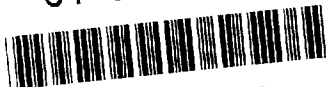

**WHEREAS**, I, Won H. Lee, now own the entire right, title and interest therein; and,


