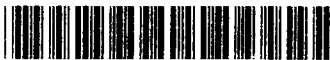



ASSIGNMENT

WHEREAS, I, Raffaele Zambrano (hereinafter referred to as ASSIGNOR), having a post office address of Via Petrone, 69, 95029 Viagrande, Italy, am the sole inventor of an invention entitled "ROM MEMORY CELL NOT DECODABLE BY VISUAL INSPECTION," as described and claimed in the specification for which an application for United States letters was filed on June 5, 2001, and assigned Application No. 09/875,448, claiming priority based on an application filed in Italy identified by Application No. TO2000A000543, filed June 6, 2000.

ASSIGNOR hereby authorizes and requests the Commissioner of Patents and Trademarks to issue all letters patent on said invention to ASSIGNEE. ASSIGNOR agrees to execute all instruments and documents required for the making and prosecution of applications for United States and letters patent in all countries of the world on said invention, for litigation regarding letters patent, or for the purpose of protecting title to said invention or letters patent therefor.


