WHEREAS, we, Mark Fritsche, 503 Chapel Court, Eagan, MN 55121, USA, Dan Berg, 2621 Pillsbury Avenue South, Minneapolis, MN 55408, USA and Jason Johnson, 3142 Lyndale Avenue South, Apt. such applications or patents, by giving testimony in any proceedings or transactions involving such applications or patents.

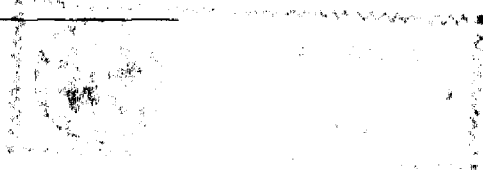

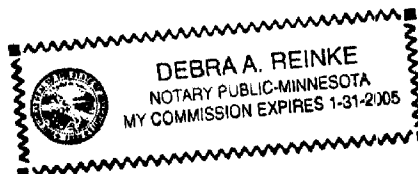
