ASSIGNMENT

Whereas, Fred Chen of the City of Taipei, Taiwan, Republic of China, has invented certain new and useful improvements related to method and apparatus for SIMULATED CHRISTMAS TREE, as described in a U.S. patent application bearing such title and Atty. Fred Chen agrees on behalf of himself, his successors, heirs and assigns, that upon request of the assignee and without any further payment or compensation, to communicate to the assignee any facts relating to said invention including evidence for interference purposes or other legal proceedings, to testify in any interference or other legal proceedings, to execute and deliver all lawful papers, and generally to do everything possible to aid the assignee to obtain and enforce patent protection for said invention in the USA, Taiwan or any foreign country.

Fred Chen further agrees that this instrument shall be governed and construed under the laws of the State of New Jersey, USA, without effect to conflict of law principles of the State.
