# ASSIGNMENT

WHEREAS, I, Helmut Reichelt of Altenzellerstrasse 13A, D-01069, Dresden, Germany have invented certain new and useful improvements in *Heating Arrangement* for a German patent application number 198 49 432.7 which was filed on October 27, 1998 and a corresponding application was filed as International Application PCT/EP99/07853 on October 9, 1999; and corresponding National Phase Application is being filed in the United States contemporaneously with this Assignment.

I hereby authorize and request the Patent Office to issue any and all of said Letters Patent, when granted, to Molekulare Energietechnik AG as the assignee of my entire right, title and interest in and to the same.

Further, I will communicate to Molekulare Energietechnik AG any facts known to me respecting said invention, and testify in any legal proceedings, sign all lawful papers, make all rightful oaths, and generally do everything possible to aid said Molekulare Energietechnik AG, its successors and assigns, to obtain and enforce proper protection for said invention in the United States, and in any and all foreign countries.
