Sumitomo Chemical Company, Limited, hereby represents and warrants that there are no rights or interests outstanding inconsistent with the rights and interest granted herein and that Sumitomo Chemical Company, Limited will not execute any instrument grant transfer any rights or interests inconsistent therewith, and Sumitomo Chemical Company, Limited binds itself and heirs, executors, administrators, employees and its representatives, as the case may be, to execute and deliver to the said Sumika Fine Chemicals Company, Ltd., its successors and assigns, any further documents or instruments and do any and all further acts that may be deemed necessary by the said Sumika Fine Chemicals Company, Ltd., its successors and assigns to file applications for improvements and inventions in any country where it may elect to file such applications, and that may be necessary to vest in the said Sumika Fine Chemicals Company, Ltd., its successors and assigns, the title herein conveyed, or intended so to be, and to enable such title to be recorded in the United States and foreign countries where such application applications may be filed.

AND, Sumitomo Chemical Company, Limited further covenants and

agrees, in consideration of the premises, that it, its executors and administrators will, at any time upon request, communicate to the said Sumika Fine Chemicals Company, Ltd., its successors and assigns, any facts relating to the said invention and improvements and the history thereof, known to it or its successors and assigns, and that it will testify as to the same in any interference or other proceeding when requested to do so by the said Sumika Fine Chemicals Company, Ltd., its successors and assigns.

The undersigned hereby grants the law firm of Birch, Stewart, Kolasch & Birch, LLP the power to insert on this Assignment any further identification which may be necessary or desirable in order to comply with the rules of the U.S. Patent and Trademark Office for recordation of this document.
