WHEREAS, I, JOHN BRUSTAD, of the County of Orange, State of California , have invented certain new and useful improvements in and for a SURGICAL ACCESS DEVICE WITH FLOATING GEL SEAL, for which the said JOHN BRUSTAD has this 9th day of January 2002, executed application papers for United States Letters Patent thereon;

BRUSTAD by these presents, sell, assign, and transfer unto Assignee, its successors and assigns, the full and exclusive right, title, and interest for the territory of the United States of America and all countries foreign thereto (including the right to apply for Letters Patent in foreign countries in its own name and to claim any priority rights for such foreign applications to which such applications are entitled under international conventions, treaties, or otherwise), in and to the said invention as described in said application, and in and to all Letters Patent granted therefore, and all divisions, reissues and continuations thereof, and we hereby authorize and request the Commissioner of Patents and Trademarks to issue all Letters Patent on said inventions or resulting therefrom to said Assignee, as assignee of the entire right, title and interest, and we covenant that we have full right so to do and agree that we will communicate to said Assignee, or its successors, any and all facts known to us regarding said invention whenever requested, and will testify in any legal proceeding, sign all lawful papers, execute all divisional, reissue, and continuation applications, and generally do everything possible to aid said Assignee, its successors and assigns, to obtain and enforce proper patent protection for said invention in all countries.

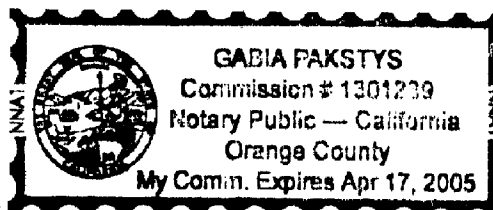
