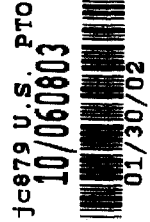

WHEREAS, we are the joint inventors of certain new and useful improvements in **TELEVISION RECEIVERS AND METHODS FOR PROCESSING SIGNAL SAMPLE STREAMS SYNCHRONOUSLY WITH LINE/FRAME PATTERNS** for which an application for United States Letters Patent has been executed by me concurrently herewith, and
